Sun Pharma Profit Drops to ₹2,023 cr

Mumbai: Sun Pharma on Thursday reported a 2% year-on-year (YoY) drop in net profit to ₹2,023 crore in Q1FY24 due to exceptional items worth ₹323 crore. The company reported net profit of ₹2,061 crore during the corresponding quarter of the same period.

Revenue rose 10.7% YoY to ₹11,785 crore in Q1FY24. Excluding exceptional items, net profit for Q1FY24 has grown 13.8% to ₹2,345 crore. The exceptional items included ₹149 crore impairment charge of an acquired intangible asset under development, ₹123 crore loss on foreign exchange loss pertaining to Ranbaxy Nigeria due to devaluation of local currency...
