Transaction Overview




- Acquisition of 100% stake in the business conducted by The Beverage Company (Proprietary) Limited, South Africa along-with its wholly-owned subsidiaries ("BevCo"), with an option to accept minority co-investment from large equity fund, subject to regulatory and other approvals (if any) including but not limited to PepsiCo Inc. and Competition Commission South Africa.
- > BevCo is engaged in the business of manufacturing and distribution of licensed (PepsiCo Inc.) / own-branded non-alcoholic beverages in South Africa.
- > Bevco has franchise rights from PepsiCo Inc. in **South Africa**, **Lesotho and Eswatini**. Further, it also has distribution rights for **Namibia and Botswana**.
- Proposed transaction is at an Enterprise Level is valued at ~ ZAR 3 Billion (~INR 13.20 bn; 1 ZAR = 4.4 INR). BevCo achieved net revenue of ZAR 3,615 mn (~ INR 15.90 bn) in FY23.

Soft Drinks in SA – Largest market in Africa




Largest Soft Drinks Market in Africa....

- Total population is 60mn out of which 65% between 15-64 age group.
- Urbanization is between 60%-80%.
- The rising affluence of South African households has resulted in urbanization, coupled with longer workdays and emerging interest from female consumers, which has contributed to the growth in the Industry.

Soft Drinks Industry – Market Share 2022

- The beverage industry is dominated by B-brands with a market share of as much as half of its size.
- Amongst the global brands in the balance half, PepsiCo has insignificant low single digit market share.
- Product portfolio innovation with favourable demographics coupled with thrust on Go To Market Strategy shall drive the lateral growth across segments.



- Refreshhh: High caffeine content drink available in 2L, 1.5L and 330ml bottles as well as 500ml can.
- **Reboost:** Energy drink available in 500ml can.
- Coo-ee: Carbonated drinks in classic flavours (like Cola and Iron Brew) and unique flavour fusions like Mango, Cranberry and Pink Lemonade. Available in four different pack sizes (2L, 1.5L, 1.25L and 300ml).
- **JiVE:** Fizzy Pink Lemonade, Blue Cream Soda & Kola flavours in 500ml and 2L packaging



Manufacturing Footprint in South Africa





- *BevCo has **five manufacturing facilities** two in Johannesburg and one each in Durban, East London and Cape town.
- ❖Total installed capacity is ~ 3,600 BPM and peak month capacity is ~22 million 8oz cases.
- ❖There are total 15 beverage manufacturing lines - 13 for PET and 2 for CAN. Apart from this, company has 1 BIB Line and 1 Pouch line.
- Out the 5-manufacturing facility, 3 plants are PepsiCo accredited plants, i.e. Boksburg (JHB), Amanzimtoti (Durban) and Epping (Cape Town).
